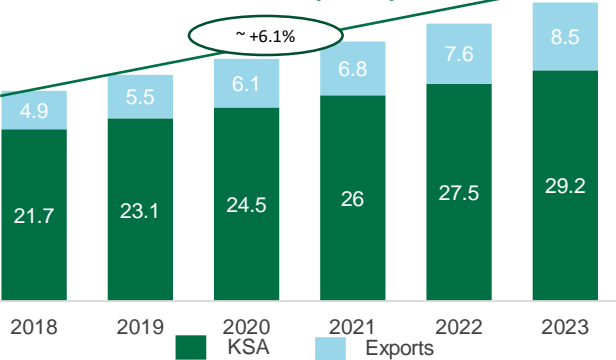

The Kingdom is currently mostly covered by a network of distributors , and one known local manufacturer

CURRENT IMPORTERS

Japan accounts for 35% of the supply, USA 22%, Germany 12%, and the rest is supplied by a mix between Asian and Western European countries

EXISTING CAPABILITIES

- Capability exists for producing repurposing kits for ambulances
- Needs Transfer of Technology for rest of emergency portable equipment
- Needed consumables and other commodity technology devices can be sourced inside Kingdom

- Stainless steel and other metal fittings
- Portable devices for ambulance
