



Elite International School

- Elite International School is a K-12 school under construction in KEC and is slated to open by September 2022
- The school will span an area of 20,000 m² and will have a capacity of 1,700 students
- The school will offer 3 international tracks for its students: American Track (SAT), British Track (Cambridge), and Global Academic Track (IB)



Land Allocation:

Land has been allocated through a lease agreement of 25 years which is renewable for another 25 years within the designated knowledge cluster





Revenue sharing agreement for KEC:

KEC will receive a percentage of income generated from all licensed activities of the school



School Development:

KEC has awarded the contract for developing Elite Schools to contracting company MOBCO which has completed several projects across KSA
